WHAT DOES THE FUND INVEST IN?			
<p>The investment objective of the Fund is to achieve long-term capital growth and modest income by primarily investing, directly or indirectly, in a diversified mix of global Canadian and global securities. The Fund intends to achieve its investment objective by investing primarily in underlying exchange-traded funds (ETFs) that are listed on North American stock exchanges.</p> <p>To achieve the Fund’s investment objective, the Manager will use an active, top-down multi-asset approach to portfolio construction and management across global risk factors. The Manager will combine a long-term view of global macro trends with a short-term cyclical outlook with the aim of determining optimal asset allocation. The Fund may invest, directly or indirectly, in equity securities, fixed-income securities, commodities and currencies from around the world and will seek to generate income through globally diversified income-oriented investments. The Fund seeks to provide stability through various investment climates with an emphasis on risk management and low volatility. The Fund may invest, directly or indirectly, up to 100% of its net assets in foreign securities.</p> <p>The charts below give you a snapshot of the Fund’s investments on June 30, 2025. HOW RISKY IS IT?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a Fund’s returns change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

RISK RATING

Forstrong has rated the volatility of the Fund as **Low to Medium**.

Because this is a new fund, the risk rating is only an estimate by Forstrong. Generally, the rating is based on how much the Fund’s returns have changed from year to year. It doesn’t tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, the Fund doesn’t have any guarantees. You may not get back the money you invest.

WHO IS THIS FUND FOR?

INVESTORS WHO:

- want to gain exposure to a diversified mix of Canadian and global securities,
- have a low-to-medium risk tolerance and are seeking to grow their capital over the long-term, and
- can handle the volatility of returns generally associated with equity investments.

The Fund is not an appropriate investment if you have a short-term investment horizon.

A WORD ABOUT TAX

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

HOW MUCH DOES IT COST?

This section shows the fees and expenses you could pay to buy, own and sell Class A units of the Fund.

The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. SALES CHARGES

No sales charges apply when you purchase Class A units of the Fund.

2. FUND EXPENSES

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

The Fund's expenses are made up of the management fee, operating expenses and trading costs. The class' annual management fee is 1.50% of the class' net asset value. Because this is a new fund, operating expenses and trading costs are not yet available.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and/or advice that your representative and their firm provide to you. Your representative's firm may pay part of the trailing commission to its representatives.

Forstrong pays your representative's firm a trailing commission. The trailing commission is paid out of the management fee. The rate for this series of the fund is 1.00% of your investment each year. This equals \$10.00 each year for every \$1,000 invested.

3. OTHER FEES

You may have to pay other fees when you buy, hold or sell units of the Fund.

FEE	WHAT YOU PAY
Short-Term Trading Fee	If you switch or redeem units of the Fund within 30 days of purchasing such units, then a fee of 2% of the amount switched or redeemed may be charged by the Fund to you or your account may be restricted or closed. The fee goes to the Fund.
Switch Fee	Your representative's firm may charge you a switch fee or a redesignation fee, as applicable, of up to 2% based on the net asset value of the applicable class of units of a Fund you switch or redesignate. You may negotiate the amount with your representative. Dealers' fees for switches and redesignations are paid by redeeming units held by you.
